2015 CRAFT & SERVICE VENDOR INFORMATION, RULES & REGULATIONS

General Information:

The Fright Planet Park is open on select nights from October 2 – October 31, 2015 at Cal Expo (the home of the California State Fair) in Sacramento, California. On the nights that the Park is open, the gates open at 7:00 PM. Closing times vary per night. This is an outdoor event and the Park is open rain or moonshine. We want our Guests to be able to experience your product or service on all the nights that we are open, and we give top priority (and a big discount) to those vendors who are willing to operate their booth on every operational night.

Vendor Eligibility:

Vendors selling or offering original craft, products, or services will be given preference, especially with those vendors who have a booth that goes hand-in-hand with a haunted theme park. Manufactured and mass-produced items are accepted on a very limit basis only when the product compliments the overall theme of the event.

Vendor Fees:

- \$1,200 – Every night that Fright Planet is open in 2015.
- \$500 – Any one Friday or Saturday, or Halloween night.
- \$300 – Any other weekday night, including Sunday.

General Rules:

- All display and merchandise must be placed within your 10' X 10' space. Items may not extend into the street more than 10 feet from the curb or extend behind your booth space.
- **Paths around your booth must remain open and clean at all times.**
- Fright Planet does not allow the use of generators.
- No flammable or harmful items may be sold or displayed.
- No booth sharing is allowed.
- Overnight security will be provided. Each vendor is responsible for securing their booth.
- Fright Planet is not responsible for any loss or theft incurred.
- Vendors are responsible for removing all trash from their area each evening and must use the Park dumpster for disposal.
- Vendor must notify Fright Planet immediately of any cancellation. No refunds will be granted within 30 days of the Park opening.

Application Procedure:

- Completed application must include a picture of your booth setup and pictures of your merchandise.
- Vendors will be notified in a timely manner of their acceptance status **by email**. Those accepted will receive space assignment and set-up information.

Special Note:

Accepted vendors will not be allowed to use the name "Fright Planet" or any of the Fright Planet logos on their products without written permission from Fright Planet.
